Mission Revision

Over the course of FY22, archivist, Jordan Mitchell engaged in a Preservation Assessment with the Northeast Document Conservation Center (NEDCC) As part of this work we are proposing a revision to CCTV and the Town Meeting TV mission statements to more accurately reflect the importance of the archives in the work we do.

Accepted: **Town Meeting TV** is a trusted producer, educational and equipment resource, and community archive of video providing access to local government and facilitating engagement in local democracy. Town Meeting TV is Chittenden County's regional government access TV channel overseen by municipally appointed representatives from Burlington, South Burlington, Essex, Essex Junction, Williston, Winooski, Colchester, and St. George. Town Meeting TV programs are made available on Comcast 1087, Burlington Telecom 17 & 217, as well as at www.CH17.TV

Digital Capacity Grant

CCTV was awarded a grant from the VT Arts Council to support the set up of hybrid systems at 3 locations in the community. These will be used to produce cultural

programs and test accessibility workflows. In November, we will be inviting staff and community members to join us for accessibility study circles. Town Meeting TV will undertake this work as part of its commitment to Opening the Doors to local government.

Contract Dashboard EOY

Between 10/1/21 and 9/30/22, Town Meeting TV produced and supported 1313 programs (nearly 1500 hours) for our member communities; 397 were categorized as municipal coverage. It is worth noting that based on the averaged unit cost analysis of 5 hours per program this represents approximately 6,500 labor hours.

Channel Outage

On Wednesday afternoon, November 23 the playback system we share with the Media Factory, named the Hypercaster, experienced failures. Upon review by our technical support contact they determined it was a failed boot drive. This playback system allows us to schedule programming for BT channel 317, BT channels 217/17 and Comcast channel 1087. The latter 3 channels are redundant, the first, channel 317 plays Burlington live meetings and other Burlington specific programming. The Hypercaster was packed up and shipped to Telvue for repair. Before the end of the day on Wednesday all of our channels and the Media Factory channels were rerouted to play VT Community TV programming. VCTV is a statewide channel that airs on Comcast 1070 and is made up of channel content from access centers around the state. Over the course of the vacation weekend, and the following week

we waited for the system to be repaired and our regular channel content was not scheduled instead viewers tuning in could watch VCTV content.. The Hypercaster was returned and reinstalled, media was reloaded and reindexed for playback on Friday, December 2. By Monday, December 5th our channels were once again on the air and playing back our regular content.
