Narrative:

On 12/26/15 at approximately 2115 hours, dispatch received a 911 call from (DOB:) reporting he placed a "Black lives matter" sign on his lawn and came home to find a dead black cat in a bucket on his lawn. Said he could also hear voices and people running around his house.

Trooper Steven Fauteux and I arrived a crass the street and went to inspect it and found a dead black cat. Said he recently placed a "Black lives matter sign" on his lawn and he thinks this may be related. Trooper Fauteux and I checked the perimeter of the residence and did not observe anything suspicious. The bucket with the deceased cat was located across the street from the residence. It could not be determined how the cat became deceased, but it appeared the cat was not killed in a malicious way as it was fully intact with little blood appearing in the bucket or the bag it was in. There was no collar on the cat identifying a name or owner.

did not observe any individuals leave the bucket or observe anyone on the perimeter of his residence when he heard voices.
