The City is in receipt of your public records request dated July 14, seeking:

"All communications, including but not limited to emails, text messages, memos, and internal reports, sent or received by City Councilor Becca Brown McKnight between May 1, 2025 and the present that reference or include data from the Chittenden County Sheriff's Department or any other entity regarding a reported decrease in heroin use, crack use, public defectation, sex solicitation, and related criminal activity in the Marketplace Parking Garage, specifically in connection to the relocation of the Food Not Cops lunch distribution to City Hall Park.

This request is prompted by Councilor Brown McKnight's public statement during City Councilor Items at the Monday, July 14, 2025 Burlington City Council meeting, where she referenced information allegedly provided by the Sheriff's Department citing a 75% decrease in these activities.

Please include communications between Councilor Brown McKnight and the Chittenden County Sheriff's Department, as well as any communications with City of Burlington departments, elected officials, or outside agencies related to that claim.
