On Sunday 9/18/22 at 1301 hours, during the PRIDE March, we received a report categorized as a "Disturbance," in which a caller advised that a male at Church St and Bank St was allegedly carrying an offensive sign and was upsetting people in the parade. The caller stated that someone dumped coffee on the person with the sign. At 1305 hours, a second caller alleged that the man with the sign elbowed her friend, and her friend wanted to speak with police. With no immediate life-safety component, this call was stacked as part of the Priority Response Plan.

On Sunday 9/18/22 at 1553 hours, more than two hours after the PRIDE March ended, we received a report from a nurse at the UVMMC Emergency Dept who stated that a patient advised that he had been assaulted at the parade and wanted to make a report. As it was an incident in the past, and the Priority Response Plan was in effect, response was delayed. An officer contacted the hospital at approximately 1830 hours and learned that the man was no longer at the hospital and the phone number on file was not valid.

If additional information becomes available, particularly if complainants come forward, the BPD will take appropriate next steps.

# LGB ALLIANCE VT Protests Outright VeFinerit'sck Pull After Attack on 74-Year-Old Stonewall Veteran, Demand Anti-Violence Pledge

Burlington, VT – October 1, 2022 – LGB ALLIANCE VT are having a silent protest today at Outright Vermont's 2022 Fire Truck Pull in response to the attack on Fred Sargeant at Burlington Pride Parade and Festival 2022.

Fred Sargeant, a 74-year-old veteran of the 1969 Stonewall Riots in New York City and one of the last surviving founders of the original 1970 Christopher Street Gay Liberation Pride Parade was attacked, assaulted and robbed on Church Street at the Burlington Pride Parade on Sunday September 18h, parade participants who were marching with the Outright Vermont group were the first to confront Mr Sargeant and steal his property.

After Outright Vermont marchers began the assault on Sargeant other members of the crowd joined in. LGB ALLIANCE VT believe Outright Vermont marchers initiated violence upon a gay, disabled man, which is both homophobic and ableist.

The LGB ALLIANCE VT demand Outright Vermont issue anapology to Mr Sargeant attack and publicly forbid participants at all Outright Vermont events from instigating violence in Video of the attack is available at https://www.youtube.com/watch?v=uljJu2QDvTI.

The LGB ALLIANCE VT are also protesting several of Outright Vermont's practices. Outright Vermont has fomented a climate of homophobic hate directed at numerous lesbians and gay men in our community by endorsing "FUCK TERFS" messaging in their parade group.

Outright Vermont advocates for the medical transitioning of children including off label use of so called "puberty blockers" which have recently been issued an FDA warnings citing harms to minors, cross sex hormones, and cosmetic surgical mutilation of one's body and sterilization. Minors can apply to receive free "packers", which are realistic prosthetic penises, and "breast forms", which are prosthetic breasts. "Chest binders" and mastectomy bras are also available. The effects of breast binding before the heart, lungs, spine and rib age have had time to mature is just not known. These items may be given to minors without parental notification or consent.

These citizens are also concerned about the rise in anti-woman and anti-police sentiment in Burlington. They point to graffiti on Pearl Street Beverage in downtown Burlington as an example. Pictured below, the graffiti says; "Fuck TERFs" (trans-exclusionary radical feminists). A derogatory term, "TERF" a slur which refers to biological women who criticize the trans movement on the grounds that some allegedly pro-trans policies threaten women's lives, safety and freedom.

The graffiti also says "ACAB", meaning all cops are bastards. "I hate pigs and you should too" is more anti-police graffiti, as "pigs" is a derogatory term for police. Given the rise in violent crime in downtown Burlington, citizens are concerned that anti-police discrimination threatens officers' safety.

Mr. Sargeant is not available for comment today.

Most here don't know me. I'm from Addison County. I was the person who came to Burlington two weeks ago to protest what Pride has become - a misogynis@c, homophobic, exclusionary event.

My name is Fred Sargeant. I have been a lifelong gay rights advocate and ac@vist. I joined the gay rights movement before the Stonewall Riots. I was the first manager of the first lesbian and gay bookshop in the world, where I worked alongside my partner, gay rights pioneer, Craig Rodwell. We were at the Stonewall riots together when they began. We remained through all the nights of rio@ng - leafleKng, organizing, and demonstra@ng.

In the fall of 1969, four of us went on to propose and then organize the very first Pride march, which was not a parade. No floats, no corpora@ons and no massed con@ngents of drag queens and other fe@shists, which is precisely what Burlington Pride has become. Burlington Pride is no longer even held in June, as it tradi@onally has been to commemorate the riots that started on June 28.

Burlington Pride has now become a plaUorm for misogyny, exclusion and hate. "Gay" is now defined by the Pride Center of Vermont as a term of erasure; no member of their team or board iden@fies as gay, just as queer. Queer theory seeks not

only to erase societal norms and values, it seeks to erase LGB people from the movement that they created.

Three years ago, through the LGB Alliance in the UK, I met people like myself, long@me same-sex rights ac@vists who, like me, had become dismayed at the direc@on that the movement that we had created had taken. Since then, it's been my honor to help found a USA chapter of the LGB Alliance and to facilitate the crea@on of LGB Alliance VT. In three short years, LGB Alliance UK has grown to more than a score of affiliated chapters, spanning 4 con@nents.

Our purpose as members of LGB Alliance is to ensure that lesbians, gay men and bisexuals can live free from discrimina@on or disadvantage, based on their sexual orienta@on.

We are not an@-trans ... but will not take a backseat to anyone in the movement that we created.

I have likened the present LGBTQ+ movement to a marriage gone terribly bad. The TQ+ part has become irreversibly domineering and abusive. And like all such chronically abusive rela@onships, beyond repair. Our interests are too different.

At the LGB Alliance, we achieve our goals and purpose by

advancing lesbian, gay and bisexual rights.

We will ensure that the voices of lesbians, gay men and bisexuals are heard in all public and poli@cal discussions affec@ng our lives.

By amplifying lesbian voices, we highlight the dual discrimina@on faced by lesbians in a male dominated society.

We protect children who may grow up to be lesbian, gay, or bisexual from harmful, unscien@fic ideologies that may lead them to believe that either their personality or their body is in need of changing. Any child growing up to be lesbian, gay or bisexual has the right to be happy and confident about their sexuality and who they are.

We promote free speech on lesbian, gay and bisexual issues.

We promote freedom of speech and informed dialogue on issues concerning the rights of lesbians, gay men and bisexuals. We assert that different opinions, even those we may disagree with, should be heard as part of the public debate.

We discuss, propose, and oppose ideas; we do not aeack individuals. Disagreement does not equal hate. We do not condone, endorse, or encourage any abusive or discriminatory

behaviour toward any group or individual.

As John Adams said, facts maeer. Our approach is to consider the evidence to make informed decisions and communicate in a factual and honest way. Legisla@on, policy, guidance, and decisions that affect lesbians, gay men and bisexuals must also be based on evidence.

We uphold the legal and scien@fic defini@on of homosexuality as sexual orienta@on toward people of the same sex, and of bisexuality as sexual orienta@on toward people of either sex.

We recognize that sex is binary, female and male, and that (for the vast majority of people) sex is determined at concep@on, observed at birth (or in utero), and recorded. We reject the coop@ng of rare medical Differences in Sexual Development (DSDs/intersex condi@ons) in order to cast doubt on the binary nature of sex.

We support women's rights and bodily autonomy. We stand with lesbians in rejec@ng pressure to accept as sexual partners, or admit into lesbian spaces, males who define themselves as women. We stand with gay men in rejec@ng pressure to accept as sexual partners, or admit into gay men's spaces, females who define themselves as men.

We are not a poli@cal en@ty. We are non-par@san. Our membership holds diverse poli@cal views.

Again ... we are not an@-transgender. My first interview aler this event is with a West Coast trans male influencer who shares my concerns.

The Pride Center of Vermont is an organiza@on that has advocated for public disrup@on in the past.

At the parade, the first person to aeack me and steal my signs was from the Outright Vermont unit. Others in that group, and from other groups, joined his aeack. Repeated aeempts were made by the Burlington Pride gangs to steal my signs and to undemocra@cally end my silent protest. I was assault by a number of people, and when it was clear that I would not leave and end my protest, I was knocked to the ground by the gang.

I call on Outright Vermont to denounce the violence that originated within their group, commit to educa@ng their membership on respect for civil rights and their elders, and to cooperate fully with the police inves@ga@on now underway.

Earlier this week, a Bri@sh group called Mermaids - that shares objec@ves in common with Outright Vermont - was placed under inves@ga@on by the Charity Commission for offering unsafe and medically unnecessary "chest binders" to children

without parental consent or knowledge, in just the same way that Outright Vermont makes these dangerous devices available to Vermont children and also without parental consent and knowledge.

I also call on the Pride Center of Vermont to denounce and condemn the violence at their parade.

Given their failure to conduct a safe Pride event, I call on the Pride Center to relinquish control of the event to a community-wide group of stakeholders, and to commit to restoring the event to June, as it was always meant to be.

I call on Mayor Weinberger to finally issue an unequivocal condemna@on of the unwarranted violence by members of Outright Vermont and other Burlington Pride par@cipants ... and without the BUT that he seemed to want to add at his September 21 morning mee@ng. The world is watching, Mayor Weinberger. When a friend, JK Rowling, saw what gender fascists did to the women in Brighton, England, and to me here in Burlington, VT, she said -- the violence is not a bug, it's a feature of this authoritarian gender movement.
