MEMORANDUM FOR DISTRIBUTION

**In re: Trooper Giancarlo DiGenova, Vermont State Police**

Dear Counsel:

It has come to my attention that Trooper Giancarlo DiGenova, of the Vermont State Police – Williston Barracks, and formerly, of the Middlesex (Berlin) Barracks, is the subject of multiple criminal investigations.

Trooper DiGenova is under active investigation for multiple offenses of grand and petit larceny, in violation of 13 V.S.A. §§ 2501-2502, neglect by a public officer, 13 V.S.A. § 3006, possession and sale of stolen property, in violation of 13 V.S.A. § 2561, and official misconduct in violation 20 V.S.A. § 2401. Specifically, Trooper DiGenova is suspected of accessing and removing personal property of offenders that is in the custody and control of the Vermont State Police. Further, preliminary review of the available investigative materials suggests that Trooper DiGenova has been deceptive or untruthful with investigators – based on his assertions appearing to be contradicted by other evidence and information.

Although there is no evidence to suggest that Trooper DiGenova's reports filed in your client's cases are not accurate, that the rights of any other individuals were violated, or that any other evidence or information was mishandled, this information is being disclosed consistent with the State's Constitutional and ethical requirements, including V.R.Cr.P. 16(a)(2)(G) and (b)(2) to ensure awareness of this matter for purposes of discovery planning and disposition of pending cases where Trooper DiGenova was involved.
