On 07/05/24 at approximately 2147 hours, 911 was called regarding an assault on caller Lydia Diamond at Broadacres Bingo.

Upon arrival I came in contact with Garner Temer, the manager at Broadacres Bingo. Temer told me that Diamond was cursing at staff and told the manager to, "go fuck himself". Temer then asked Diamond to leave. Temer informed me that he wants Diamond trespassed from Broadacres Bingo. No contact was made with Diamond, as she was not at the location.

I watched security footage of the incident, and observed Diamond visibly upset with the Broadacres Bingo staff. The footage shows an employee walking to Diamond and then Diamond becoming upset. It then shows Temer interacting with Diamond and eventually telling her to leave. The footage did not show Temer assaulting Diamond or even coming close to her

I tried contacting Diamond via phone call about the incident, but no contact was made.
