On 10/08/2022 at 1712 hours, Lydia Diamond arrived at the Colchester Police Department to report harassment from the owner of Broadacres Bingo. Upon making contact with Diamond, she advised that Garner Temer regularly yells at her to fix her parking when she arrives at the bingo hall. Diamond also reported that she had previously been trespassed from the property for no reason (trespass notice since expired). Diamond informed me she believed she was being discriminated for her race, age, and disability. I provided Diamond with contact information to the civil rights unit of the VT Attorney General's office.
