Parade Detail for memorial day parade. We used our normal parade route from Field Ave. to Gardner park with traffic detoured to keep flowing around parade route. Parade stepped off at 10am and was concluded by 10:20 am. Traffic was opened up back up at conclusion of parade. Sgt. Rivers and two other officers stood by at ceremony. We blocked off the entrance to Gardner park with a cruiser on the causeway side and another on the other side of the roundabout. This was done for safety reasons as part of the ceremony is throwing flowers off the bridge into the river and a 21 gun salute from the bridge by the American Legion. This was closed for the entire ceremony which was about 1 hour. The entrance to Gardner park from the Western Avenue side was still accessible.
