## Vermont DOC Supervision Fee Payments

**Tuesday, January 18, 2022 – 10:00am**

*To better align ourselves with evolving technology and ease the burden on those under supervision, we are excited to announce an update to our Supervision Fee payment processing.*

*Effective January 18, 2022, the Vermont Department of Corrections (DOC) is moving to a [web-based portal](https://appengine.egov.com/apps/vt/doc/fines-fees) for Supervision Fee payment processing. <https://appengine.egov.com/apps/vt/doc/fines-fees>*

*DOC has utilized the [Offender Payment Coupon](#) which limits the payments of Supervision Fees to only bank checks and money orders. With this new portal, personal credit cards, VISA/Mastercard enabled Debit Cards, and electronic checks will be allowable at no additional cost to the individual. When payments are submitted through the [portal](#) an emailed receipt specifying your transaction details will be sent to you as backup documentation for the payment made.*

*The Offender Payment Coupon along with physical bank checks and money orders will be phased out over the next year (January 2022-January 2023). You are encouraged to explore the [new electronic Supervision Fee process](#) and submit any questions you have to your current or former Probation & Parole Officer.*

This payment option allows for a bank check or money order to be sent into the lockbox along with a printed payment coupon. Please be aware this option will be phased out during calendar year 2022. Payments made with this coupon are for Vermont DOC Supervision Fee's only.
