Narrative: On 9/8/17 at 1209 hours, Kurt Cotanch called from [REDACTED] Andersonville Road in Glover to report vandalism to one of his barns. He advised sometime after 2000 hours on 9/7/17 his barn was spray painted with , " GET OUT" along with swastikas on the side of a barn and "Nigger". While I was there one of the farm workers advised the same thing was spray painted on the roadway, mailboxes, signs and posts on Mud Island Road in Glover. There are no suspects at this time. They did advise they had a worker who [REDACTED] after he was told to take his [REDACTED] down. They didn't want this person contacted in case it was him and he retaliated. They did advise there was a surveillance camera that would be able to [REDACTED] I asked them to make me § 317(c)(5)(D) a copy of the surveillance video and to call me as soon as this was done. They advised they are able to scrape off most of the paint which was a light brown and black and will paint over it with white. \$100 damage. I was advised by Orleans Sheriff's that Deputy Testut took the call on Mud Island Road for the vandalism 170LC2006.

On 09-12-17 I was asked to follow up on this investigation. I responded to the farm, Jasper Hill Farm located at █████ Andersonville Road in the Town of Glover. I was not able to locate anyone at the farm, however, I was able to locate a █████ at the residence that is located on the farm land. The █████ identified █████ as █████ DOB: █████, and advised that █████ was also an employee of the farm.

I asked █████ if Kurt Cotanch was available, as he was the initial complainant in this case. █████ stated that he may be at the barn next door, but if not, █████ was not sure of his location. I spoke to █████ briefly advising █████ that VSP was taking this vandalism very seriously and I was there to conduct some follow-up investigation. I asked █████ who the "█████ employee" was that they thought might have done this spray painting. █████ advised that there was an employee named █████ that had recently █████. █████ stated that █████ was not sure where is was at this time, but █████ had heard that he was working at the █████ in Orleans area. █████ did not have any contact information for him. █████ stated that he hadn't worked there █████ though.

I asked █████ if █████ had heard any rumors or talk around town since this incident and █████ advised that █████ hadn't. I asked █████ if anything else had occurred since the initial incident and █████ said that nothing further has occurred. I asked █████ if █████ would either contact myself or Cpl Field if █████ heard anything, even if █████ didn't think it was important because VSP was taking this vandalism very seriously and would follow-up on any lead.

I asked █████ if █████ thought that this was racially motivated or directed at anyone in particular and █████ didn't think that it was. The vandalism had been sprayed on with black and a yellow/gold paint.

I cleared from the residence, which had a mailbox that indicated that the residence address was █████ Andersonville Road.

I went to the barn next door and went inside. No one was at this location, so I left a note on the office door for someone to contact me as I was just following up on the vandalism.

After leaving the barn, I met with the neighbor █████ barn. The female identified herself as █████ She advised that she and █████ used to █████ She advised that they █████ it about three years ago to █████ She was not sure of the last name spelling. She advised that they are from the Greensboro VT area. █████ stated that she knows that both █████ (who goes by "█████" and █████ had spent some time in Columbia, but they are Vermont natives. She stated that both █████ and █████ come from a "wealthy" family. She stated that the █████ did not go so well as they had all sorts of issues that arose and their attorney had to deal with it. I asked her about the spray painted vandalism and her first thought was a █████ employee. She stated that they seem to go through employees every three months. She stated that they can see the █████ and █████ from their █████ and they see new vehicles and new faces there every few months, that was why she made this comment. She stated that █████ reputation in the neighborhood isn't that good. She stated that the way they treat people is not nice. █████ advised that they don't have any contact with anyone from the farm though. I asked █████ what her thoughts were on the

specific things that were spray painted on the barn. She stated that she honestly believes that it was not racially motivated but rather an [redacted] employee who was just angry at how they had been treated. [redacted] advised that she didn't have any first hand knowledge, that was just her guess. I asked [redacted] to contact myself or Cpl Field if she heard any rumors or anyone talking around town, as VSP was taking this vandalism very seriously. [redacted] advised that she would. She did state that all the neighbors usually know the vehicles and people that belong in the area and they would call if they saw someone unusual in the area.

I received a phone call from [redacted] DOB: [redacted]. [redacted] advised that he was returning a call to me as he had found the note I left on the office door. I advised [redacted] that I was just following up on the vandalism from last week. I asked him if he had heard anything around town or any rumors of who was responsible. [redacted] stated that he hadn't. I asked him who the [redacted] employee was that Cpl Field had referred to in her case notes. [redacted] explained that [redacted] whom he described as "a [redacted] year old [redacted] that had a bad rap in high school and around town", but was a hard worker and a good employee. [redacted] advised that a [redacted] time ago [redacted] was employed there as a farmhand and also [redacted] located on the farm property. [redacted] explained that he had [redacted] a [redacted] on one of the windows in the [redacted]. [redacted] advised that [redacted] DOB: [redacted], was [redacted] and took issue with the specific spray painting. [redacted] advised that [redacted] was offended by the [redacted] and the vandalism that was on the barn. [redacted] advised that he had gone to [redacted] and asked him to remove the [redacted] from the window. [redacted] advised that [redacted] took it down right away, without a problem. He advised that there seemed to be no issue with him asking to take it down. [redacted] did advise that about a week after he asked [redacted] to take the [redacted] down, [redacted]. He confirmed that he was not [redacted], he actually [redacted]. He again confirmed that he was a "good employee". He stated that the only reason that [redacted] thought it might have been him was because of the type of [redacted] and then the specific spray painted vandalism. He advised that no one that works for the farm believes that it was [redacted] who did it. In fact, [redacted] advised me that [redacted] from time to time to say hello and hang out for a bit. I asked [redacted] if he thought it was some random vandalism or if it was directed toward anyone in particular. He stated that he believes that there may be a meaning behind it due to the specific nature of the vandalism, however he doesn't believe that it was directed at someone. He stated that he had heard that it was found elsewhere around town as well and believes that it was just randomly spray painted on one of their barns. He advised that his [redacted] "being [redacted] was offended by it though. [redacted] advised that he did not know where [redacted] was living now, but he heard that he got a job working for a large [redacted] somewhere towards Champlain. He further advised that he believes his contact number is [redacted]. He stated that although [redacted] does not reside in the area at this time, he still has [redacted], as he grew up [redacted]

I advised [redacted] to contact either Cpl Field or myself if they heard any rumors or any talk about who did it, as VSP was taking this case very seriously and would follow-up on any lead, no matter what it was. [redacted] thanked me and advised that he appreciated that we were taking this matter seriously. He advised that he would contact us if he heard anything.

On 9/13/17 at 1431 hours myself and Corporal Amy LeClair went to the Jasper Hill farm to speak to [REDACTED] Kurt and their employee, [REDACTED] [REDACTED]). We met with Kurt and [REDACTED] who advised that they hadn't noticed any markings on 9/8/2017 the on barn until [REDACTED] notified them around 1130 hours of the swastikas and other markings. [REDACTED] advised he went by the barn on Thursday night around 2100 hours with the [REDACTED] and never noticed any markings. He advised the street light by the house was on and working, but the truck in the way didn't light up the road side of the barn. I asked him if there were any suspicious vehicles in the area lately, he advised a small green [REDACTED] style on Thursday night which was very loud went up by headed toward the Daniels Road. [REDACTED] advised his neighbor [REDACTED] had come to the house, on 9/8/2017 around 1130 hours with [REDACTED] to show her compassion for someone having written on the side of his barn. [REDACTED] advised he had driven by the barn at 0800 hours on Friday and never noticed it. He advised there hadn't been anything blocking the view of the barn on this day and believed he would have seen it then. [REDACTED] advised he gets to work at [REDACTED] hours each day and usually works with [REDACTED] except for Friday. [REDACTED] got off work at 2300 hours and he worked with [REDACTED].

I asked [REDACTED] if he had any visitors on Friday (9/8/2017); at first he said he didn't; it was just him and [REDACTED] Cpl. LeClair asked him if he wanted to rethink his response and she told [REDACTED] that she knew he had a visitor. He then remembered that [REDACTED] and [REDACTED] [REDACTED] sister, had stopped by around 1230 hours that afternoon of the vandalism.

I also asked [REDACTED] what happened with the [REDACTED] incident; he advised that [REDACTED] and [REDACTED] were in an argument, which [REDACTED] thought was about the [REDACTED]. It should be noted that when I spoke with [REDACTED] about the incident with the [REDACTED] [REDACTED] advised there wasn't an argument and he had only asked him to take it down. He advised [REDACTED] put the [REDACTED] up on a Friday in [REDACTED] then took it down the following [REDACTED] when asked. [REDACTED] said that [REDACTED] seemed to have a little bit of an attitude about it, but nothing more. I asked [REDACTED] who the [REDACTED] was offending and he advised him and anyone driving by. [REDACTED] advised after the [REDACTED] issue, within a week, [REDACTED] had [REDACTED], unknown why. [REDACTED] said he figured [REDACTED] had another job, he never showed up for [REDACTED] again.

[REDACTED] further advised he [REDACTED] at the [REDACTED] the Jasper Hill Farm with [REDACTED] for only a [REDACTED] and they are [REDACTED] [REDACTED] stated he [REDACTED] there after [REDACTED] 2017 and [REDACTED] the end of [REDACTED] 2017. [REDACTED] said he now lives at [REDACTED], Greensborough, VT with his girlfriend [REDACTED]. He said that [REDACTED] was only there for [REDACTED] when he was there. I asked [REDACTED] what he thought should be done to the person(s) who put the graffiti on the barn. He stated, "apologize." I asked what he thought happened and he stated that someone was probably drinking and thought it would be funny. This was almost the same answer as [REDACTED] had given when Cpl. LeClair and I met with him on [REDACTED].

Since 9/8/17 the day of the vandalism, I haven't been given the surveillance video and it has been 4 days. While myself and Cpl. LeClair were at the barn, on 9/13/2017, we asked for the video again. Kurt advised he didn't know anything about getting me the video surveillance and would ask [REDACTED] We met with [REDACTED]

who advised that he didn't have it recorded for me. He also told me that the surveillance would only show the [REDACTED] of the barn, not up by where the [REDACTED] done and not [REDACTED]. It should be noted that when I initially spoke with [REDACTED] regarding the surveillance video, he advised me the video would show the location of the [REDACTED]. [REDACTED] further advised he didn't realize that the video wouldn't have shown the [REDACTED] of the [REDACTED] until he reviewed the video himself.

[REDACTED] said he would get the video for us today (9/13/17). Prior to us leaving [REDACTED] came out to my cruiser and advised he had looked at the surveillance video and it showed a big white car, with a [REDACTED] sticker on it. He stated [REDACTED] was in this vehicle along with [REDACTED] sister.

On 9/13/17 at 1059 hours myself and Cpl. LeClair met with [REDACTED] at his residence located at [REDACTED] in the town of Richford, VT. As soon as we pulled into the driveway I noticed a dark colored SUV with a sticker on the back of it that stated, "[REDACTED]."

NOW COMES Corporal Amy LeClair, affiant(s), being duly sworn and on oath, deposes

and says the following:

On 09-13-17 at approximately 0936 hours, Sgt Debra Munson asked Corporal Callie Field and I if we would meet with [REDACTED] DOB: [REDACTED] one of the [REDACTED] employees of Jasper Hill Farm in Glover VT. It was learned from previous interviews that [REDACTED] Jasper Hill Farm, [REDACTED] started work at the [REDACTED] [REDACTED] in Berkshire VT.

Cpl Field and I arrived at the [REDACTED], which was located at [REDACTED] [REDACTED] in Berkshire VT at approximately 1038 hours. We met with a male who was milking in one of the barns. While we were meeting with him, the [REDACTED] DOB: [REDACTED], came into the barn and we spoke with him in his office. We asked if [REDACTED] worked there and roughly how long he has been employed by him. [REDACTED] advised that he did work there and that he has been there about [REDACTED]. [REDACTED] advised that [REDACTED] was not working at that moment though. He advised that [REDACTED] works [REDACTED] hours to [REDACTED] hours. He advised that he worked last [REDACTED], so he wasn't sure if he would be sleeping or not. [REDACTED] provided us with [REDACTED] address, which is [REDACTED] in Richford VT. [REDACTED] also advised that [REDACTED] [REDACTED], [REDACTED] also worked for him and that [REDACTED] [REDACTED] has been working for him for about [REDACTED] months.

After clearing from the [REDACTED], Cpl Field and I responded to [REDACTED] residence. We arrived at approximately 1059 hours. [REDACTED] mother, [REDACTED] DOB: [REDACTED], met us at the door and went to get her son, [REDACTED]. [REDACTED] met us outside the residence. This interview was recorded using my department issued audio recorder. While I was just getting [REDACTED] name and address, an older male opened the door very abruptly and appeared a bit disheveled and asked if I was aware of [REDACTED] age and that he was "[REDACTED]". He advised that "because he was [REDACTED] I shouldn't be asking him questions". I advised this male that I was there just meeting with [REDACTED] and that he was not a suspect. I asked him if he was aware of something that [REDACTED] had done or was guilty of something that I should be aware of and then would need an [REDACTED] to be there on his behalf. The older male advised that he wasn't aware of any such thing and that he just wanted me to be aware that he was "[REDACTED]". This male then closed the door and went back inside the residence.

I asked [REDACTED] if that was his father, to which he replied that it was. He advised that his name is [REDACTED] DOB: [REDACTED]. Before going any further I advised [REDACTED] that I was there to meet with him because of the vandalism that had occurred in Glover at the farm. I advised him that we were meeting with several people and past and current employees. I advised him that if he had done something or been a part of something that he was guilty of, that

we should have his father come out with us while we spoke. [REDACTED] then said, "Yeah, we can have him come out because he can verify that I work from [REDACTED] til [REDACTED] on the [REDACTED]". I advised him that I believed him about the work hours and asked if that was the only reason he wanted his father to come out. [REDACTED] advised that was it. I advised him again that if he was guilty of taking part in this, that we should have his father come out with us while we met. [REDACTED] advised that he had nothing to do with it.

[REDACTED] advised that he had heard about the incident from FaceBook and from the news. He stated that he hadn't known anything about it other than that. He stated that he knew a lot of "teens" in the area that liked to "spray paint" things in that area. When I asked him if he could provide me with any names, he stated, "there were hundreds of kids so it would be hard to just come up with a couple of names".

As we began speaking further, his father and mother ended up coming out to our location. [REDACTED] made the comment that there were a couple of [REDACTED] at Jasper Hill that were "heavy into drugs". When I asked for their names, [REDACTED] father interjected that he didn't want him to provide us with any names because it wasn't any of their business to be discussing with us, so [REDACTED] advised he didn't want to provide the names to me. I did advise both [REDACTED] and his father that we wouldn't go to these individuals and advise them who told us their names, however they still refused to provide any names to us.

[REDACTED] advised that he had been working at the [REDACTED] in Berkshire for about [REDACTED] months and that is also the length of time he has resided at this location in Richford. He advised that he only [REDACTED] for Jasper Hill Farm in Glover for a [REDACTED] months in the [REDACTED] in the hay field. He stated that while he [REDACTED], he [REDACTED] located right at the farm in Glover. Again, [REDACTED] advised that he has lived at this location in Richford for about [REDACTED] months and has been employed by [REDACTED] for about [REDACTED] months as well. Given that information, he would have moved to this location on or about [REDACTED]. (It should be noted that this wouldn't coincide with the "[REDACTED] months" that [REDACTED] stated that he was "[REDACTED] Jasper Hill Farm". Also, according to [REDACTED] employer at Jasper Hill, [REDACTED] was [REDACTED] and working at their farm [REDACTED]

[REDACTED] advised that while he was working at Jasper Hill Farm and [REDACTED] at the [REDACTED] on the farm, he was [REDACTED] with another [REDACTED] named [REDACTED]
DOB: [REDACTED].

[REDACTED] father started talking about how he saw this all over FaceBook and the news. He stated that he knew that we would be out to talk to his son, "he just knew it". I asked him why he hadn't come to us then, and he replied, "We probably should have".

When asked what [REDACTED] thoughts were on if this was directed at anyone specific, he advised that he believes that "it was probably just some drunk or stoned kid that did something stupid". He didn't think that it was a Hate Crime. He and his father stated that if it was directed at anyone, it probably would have been at his [REDACTED] at the time, [REDACTED] because the guys at the farm were always "making fun of him because of his [REDACTED]". He stated that [REDACTED] about [REDACTED] lbs and the guys make fun of him. I asked him why he thought the swastika would be directed at [REDACTED] and he really didn't have an answer for that.

I advised [REDACTED] that I had to ask him about the [REDACTED] he had hanging in the window of the [REDACTED] while [REDACTED] at the Jasper Hill Farm. At first he seemed confused, but then responded, "You mean my [REDACTED] I confirmed it was

about his [REDACTED]. I asked him what kind of [REDACTED] it was and he advised "a [REDACTED]". [REDACTED] stated it's for "[REDACTED]". His father asked, "What does that have to do with it? Does that make him guilty? I knew you were going to be asking about that. You should see the inside of our house right now". I advised him that I was certainly not accusing him of anything because one of his employers that I had already spoken to advised that he was a "[REDACTED]" for them. I also advised that they said that he [REDACTED] stopped in to visit with them from time to time. Immediately after I said that, his father made the comment that he was just at that [REDACTED] last Friday, then asked his son if it was Thursday. [REDACTED] stated that he was there on Friday visiting. He stated that "it was definitely Friday". It should be noted that Friday, September 8th was actually when this vandalism took place at Jasper Hill Farm.

[REDACTED] father mentioned something about a camera system. [REDACTED] stated that there were cameras in the milking barn. He stated that when he was hired there, they advised him about the cameras in the barn, so if he didn't want to work in that barn with the cameras he could work outside. [REDACTED] stated that he chose to work outside, but followed that comment up by stating that it wasn't because he was doing anything wrong that he didn't want the cameras to pick up on, he just preferred to work outside. I advised [REDACTED] that we were going to be getting a surveillance video from the farm. I advised them that we just had to go pick it up.

[REDACTED] father asked what the punishment was for a Hate Crime and we advised that it very rarely occurs in VT so we weren't even sure ourselves. We advised him that the Federal Task Force has already contacted us. We advised that their agency normally investigates these types of crimes, however, if we knew that whoever did this did not have any intent for this to be a Hate Crime and that it was like [REDACTED] thinks, "a drunk kid that did something stupid", and we knew that was the offender's only motivation, then VSP could potentially charge it as a vandalism. We advised them that if they heard anything, such as any names, to give us a call and we would follow up on any lead. We advised that if we could talk to the person responsible and get out ahead of the Federal agency taking it over, then we may be able to charge it as a simple vandalism, but without being able to talk to the person(s) responsible, we don't know what their intent is/was. Again, prior to clearing from this location, we advised them to call us and leave us a voicemail if they wanted, they didn't even have to leave their name if they didn't want to, just the information they wanted to pass along to us, should they hear anything.

SUPPLEMENTAL NARRATIVE OF CORPORAL AMY LeCLAIR

On 09-13-17 at approximately 0936 hours, Sgt Debra Munson asked Corporal Callie Field and I if we would meet with [REDACTED] DOB: [REDACTED], one of the [REDACTED] employees of Jasper Hill Farm in Glover VT. It was learned from previous interviews that [REDACTED] Jasper Hill Farm, [REDACTED] started work at the [REDACTED] in Berkshire VT.

Cpl Field and I arrived at the [REDACTED], which was located at [REDACTED] in Berkshire VT at approximately 1038 hours. We met with a male who was milking in one of the barns. While we were meeting with him, the [REDACTED] DOB: [REDACTED], came into the barn and we spoke with him in his office. We asked if [REDACTED] worked there and roughly how long he has been employed by him. [REDACTED] advised that he did work there and that he has been there about [REDACTED]. [REDACTED] advised that [REDACTED] was not working at that moment though. He advised that [REDACTED] works [REDACTED] hours to [REDACTED] hours. He advised that he worked last [REDACTED], so he wasn't sure if he would be sleeping or not. [REDACTED] provided us with [REDACTED] address, which is [REDACTED] in Richford VT. [REDACTED] also advised that [REDACTED] [REDACTED] also worked for him and that [REDACTED] has been working for him for about three months.

After clearing from the [REDACTED], Cpl Field and I responded to [REDACTED] residence. We arrived at approximately 1059 hours. [REDACTED] mother, [REDACTED] DOB: [REDACTED], met us at the door and went to get her son, [REDACTED]. [REDACTED] met us outside the residence. This interview was recorded using my department issued audio recorder. While I was just getting [REDACTED] name and address, an older male opened the door very abruptly and appeared a bit disheveled and asked if I was aware of [REDACTED] age and that he was "[REDACTED]". He advised that "because he was [REDACTED] I shouldn't be asking him questions". I advised this male that I was there just meeting with [REDACTED] and that he was not a suspect. I asked him if he was aware of something that [REDACTED] had done or was guilty of something that I should be aware of and then would need an [REDACTED] to be there on his behalf. The older male advised that he wasn't aware of any such thing and that he just wanted me to be aware that he was "[REDACTED]". This male then closed the door and went back inside the residence.

I asked [REDACTED] if that was his father, to which he replied that it was. He advised that his name is [REDACTED] DOB: [REDACTED]. Before going any further I advised [REDACTED] that I was there to meet with him because of the vandalism that had occurred in Glover at the farm. I advised him that we were meeting with several people and past and current employees. I advised him that if he had done something or been a part of something that he was guilty of, that we should have his father come out with us while we spoke. [REDACTED] then said, "Yeah, we can have him come out because he can verify that I work from [REDACTED] til [REDACTED] on the [REDACTED]". I advised him that I believed him about the work hours and asked if that was the only reason he wanted his father to come out. [REDACTED] advised that was it. I advised him again that if he was guilty of taking part in this, that we should have his father come out with us while we met. [REDACTED] advised that he had nothing to do with it.

[REDACTED] advised that he had heard about the incident from FaceBook and from the

news. He stated that he hadn't known anything about it other than that. He stated that he knew a lot of "teens" in the area that liked to "spray paint" things in that area. When I asked him if he could provide me with any names, he stated, "there were hundreds of kids so it would be hard to just come up with a couple of names".

As we began speaking further, his father and mother ended up coming out to our location. [REDACTED] made the comment that there were a couple of [REDACTED] at Jasper Hill that were "heavy into drugs". When I asked for their names, [REDACTED] father interjected that he didn't want him to provide us with any names because it wasn't any of their business to be discussing with us, so [REDACTED] advised he didn't want to provide the names to me. I did advise both [REDACTED] and his father that we wouldn't go to these individuals and advise them who told us their names, however they still refused to provide any names to us.

[REDACTED] advised that he had been working at the [REDACTED] in Berkshire for about [REDACTED] months and that is also the length of time he has resided at this location in Richford. He advised that he only [REDACTED] for Jasper Hill Farm in Glover for a [REDACTED] months in the [REDACTED] in the hay field. He stated that while he [REDACTED], he [REDACTED] located right at the farm in Glover. Again, [REDACTED] advised that he has lived at this location in Richford for about [REDACTED] months and has been employed by [REDACTED] for about [REDACTED] months as well. Given that information, he would have moved to this location on or about [REDACTED]. (It should be noted that this wouldn't coincide with the "[REDACTED]" that [REDACTED] stated that he was [REDACTED] Jasper Hill Farm". Also, according to [REDACTED], [REDACTED] employer at Jasper Hill, [REDACTED] was [REDACTED] and working at their farm [REDACTED]

[REDACTED] advised that while he was working at Jasper Hill Farm and [REDACTED] at the [REDACTED] on the farm, he was [REDACTED] with another [REDACTED] named [REDACTED]
DOB: [REDACTED]

[REDACTED] father started talking about how he saw this all over FaceBook and the news. He stated that he knew that we would be out to talk to his son, "he just knew it". I asked him why he hadn't come to us then, and he replied, "We probably should have".

When asked what [REDACTED] thoughts were on if this was directed at anyone specific, he advised that he believes that "it was probably just some drunk or stoned kid that did something stupid". He didn't think that it was a Hate Crime. He and his father stated that if it was directed at anyone, it probably would have been at his [REDACTED] at the time, [REDACTED] because the guys at the farm were always "making fun of him because of his [REDACTED]". He stated that [REDACTED] about [REDACTED] lbs and the guys make fun of him. I asked him why he thought the swastika would be directed at [REDACTED] and he really didn't have an answer for that.

On 9/14/17 at around 1000 hours myself and Cpl. LeClair went to the Andersonville Farm in Glover to serve a warrant on [REDACTED] or [REDACTED] for the contents of the surveillance video. When myself and Cpl. LeClair arrived at the property we were met at the barn by [REDACTED]. We told him we were there for the video. He handed me a thumb drive with part of the surveillance video. He advised that an [REDACTED] had downloaded the video for us, but did a poor job. I asked if he could at least show us the video so I could record on my phone. This only showed footage between 0000-0400 and 1900-0000 hours. I asked if it showed the [REDACTED] with [REDACTED] in it. He advised that [REDACTED] wasn't on the video as he had led me to believe on the [REDACTED] when when we had been at the property. He advised he had seen the vehicle in the driveway prior to being told about the witting on the barn. He advised us that he didn't see [REDACTED] in the vehicle, but it was [REDACTED] family. He said he had heard from [REDACTED] that [REDACTED] had been there which was reiterated by [REDACTED] on 9/13/17. They advised the reason there [REDACTED] surveillance is due to no one is at the barn 24-7. This isn't just for this particular camera, but for all the cameras in the barns as well. The warrant wasn't served. Refer to his statement for the details of the person(s) in the vehicle. Once back at the office we sent a preservation letter to AT&T Wireless on [REDACTED] phone# [REDACTED]. I also received information from Human Resources at the farm of the employees, their phone numbers and their shifts. While at the barn we took sworn written statements from [REDACTED] that the vehicle he had observed wasn't [REDACTED]. He also advised that he spoke to the [REDACTED] in the vehicle and they advised they were waiting for [REDACTED]. [REDACTED] filled out a sworn written statement as to why there is a break in the recording on the surveillance video. See his statement.

I was told that [REDACTED] was there before my arrival and/or after I arrived at the residence. No one had said that [REDACTED] made any slurs, statements or inklings that he would paint the barn. I also confirmed with [REDACTED] that the vehicle he observed was similar to [REDACTED] vehicle which is a [REDACTED]. See the statements from each employee.
