** Possible Hate Motivated Incident **

Narrative:

On May 18, 2020, I was notified of an online complaint made from a [REDACTED] from Bakersfield. This is regarding a possible hate motivated incident involving a group called the Patriot Front. See below email from [REDACTED]

Last night our village of Bakersfield lit luminarias down Main Street to say "thank you" to our local businesses, groups, and organizations, who have supported our community during the COVID-19 crisis. While I was walking through the village green I noticed a large sticker posted on one of our community lawn signs. The sign reads "Hope over Despair". The sticker I removed our sign was a Patriot Front sticker with their logo and a banner that reads "RECLAIM AMERICA". I am reporting this, not because there was a crime committed, but because I am hoping that local law enforcement is interested in knowing about and tracking even the most discrete spreading of propaganda by known hate groups in our communities. I did remove the sticker from the sign and have it in my possession.
